

Systems Integration Revenue Climbed 7 Percent in 2006

Total annual revenue from systems integration grew nearly 7 percent in 2006. Although a year-to-year comparison showing how many firms improved versus declined is not practical because ranking criteria was changed with this edition, many noted having an exceptional year in 2006. In addition, when asked about their revenue expectations in 2007, 84 percent of integrators expect 2007 revenue to increase, 10 percent expect it to remain the same, and 6 percent expect a decline.
